



# KIWICOLOUR VITOR+ZX™ PREPAINTED STEEL COIL

#### **PURPOSE**

KiwiColour supplies Vitor+ZX™ prepainted steel coil (Vitor+ZX™) for rollforming into building products including, but not limited to, roofing and wall cladding, gutters and associated flashings, garage doors, panels and internal linings.

#### **EXPLANATION**

Vitor+ $ZX^{TM}$ , comprises a steel substrate (0.4 mm or 0.55 mm) with an aluminium-zinc alloy coating (200g/m2) coated on the backside with a epoxy primer coating (5  $\mu$ m) and the topside with PVDF coating (total thickness 25  $\mu$ m).
